The institution has already begun a four-year integrated teacher training program that integrates education, basic sciences, and humanities to prepare secondary school teachers in a multidisciplinary setting.</p>

Critical thinking, higher order thinking, deeper learning, content mastery, problem solving, teamwork, communication, and other skills are among the outcomes here. This approach will be used to strengthen and structure education at Abhilashi University, making it appropriate in the current context while also being futuristic in acknowledging the many uncertainties in the evolving nature of the multiplicity of human endeavors and ecosystems. However, such assessments are still not fully achieved and require review through systematic analysis and research. Every three years, all of the university's curricula must be examined and updated to reflect new advancements.

1.1.1 - Curricula developed and implemented have relevance to the local, national, regional and global developmental needs which is reflected in Programme outcomes (POs), Programme Specific Outcomes(PSOs) and Course Outcomes(COs) of the Programmes offered by the University

The Abhilashi University, Chailchowk, Mandi, affiliated with the University Grants Commission (UGC) and is recognised by the All India Council for Technical Education(AICTE), Association of Indian Universities (AIU), Central Council of Indian Medicine (CCIM), Veterinary Council of India (VCI) and Pharmacy Council of India (PCI) and offered multiple courses in multiple disciplines like School of Ayurveda, School of Pharmacy, School of Engineering and Management Sciences, School of Physiotherapy, School of Veterinary Sciences, and School of Basic Sciences. The syllabus prepared by BOS, specifies the number of lectures, list of recommended books and assessment scheme of internal and external marks. The activity is carried out immediately after the end of the previous semester so that faculty members get sufficient time for the preparation of the course assigned to them for the next semester. Every faculty member prepares a schedule of instruction, Program outcomes (POs), Program Specific Outcomes (PSOs) and Course Outcome (COs) of the Programs/ courses offered by the University of entire semester in-line with the department's academic calendar.

Choice Based Credit System (CBCS): There are both UG and PG programs running in the college, like B.A. B.Ed., B.Sc. B.Ed., M.A., M.Sc. CBCS is the important part of the new education policy 2020. Choice based credit system provides an option for the students to select courses from the prescribed courses comprising Core, minor, elective and vocational course. Every course receives a specific number of credits.

2.2.1 - The institution assesses the learning levels of the students and organises special Programmes for advanced learners and slow learners

The University has a well-defined process for identifying and implementing additional accomplishments for both slow and fast learners. A personality development program is incorporated into the academic plan to help close the knowledge gap between slow and fast learners. Faculty members use a variety of teaching strategies in the classroom to meet the diverse needs of the students, taking into account their medium of instruction by offering extra support when needed in addressing language-related issues. The institution prepares its academic calendar in the beginning of the session; it organizes talks, workshops, seminars, tutorials for the learners, give opportunity to students to build their personality and overcome hesitations, encourage and give freedom to the faculty to transact their day to day activities. For the effective application of care of slow and fast learner, Abhilashi University has created mentoring system in each of its school. The mentor keeps in regular communication with the mentee's parents or guardians to update them on the mentee's academic progress and other activities. Reading materials, handouts, and other instructional resources are used to promote the learning of advanced students

2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem-solving methodologies are used for enhancing learning experiences

Abhilashi University has implemented a student-centered pedagogy that incorporates immersive, interactive, and problem-solving coaching mastery. This approach allows for the overall growth and development of students, hence enhancing their learning experience. Students participate in almost all of the university's most significant events as part of the faculty-recommended participatory learning program, which equips them with practical skills and talents to solve real-world challenges. For the purpose of developing their teaching abilities, teachers must create virtual groups of students by assigning them tasks and projects. It is mandatory for students to complete a project or dissertation. This allows students to put the ideas and concepts they have learned into practice in the subject's practical domains. Students must complete an industry training program during their last year of undergraduate study. The training's goal is to expose students to real-world business scenarios so they may use the information and abilities they have learned in the classroom and through lab exercises in an on-the-job setting. Following the training time, students are expected to report on their experiences and give presentations at seminars.

Specialized and intellectual skills to use, access, save, create, communicate, and distribute data appropriately using ICT devices for effective teaching and learning strategies are among the ICT-enabled activities implemented at the university. For effective teaching and learning strategies, educators use ICT-enabled devices, such as online resources. Following are few of the significant steps with the effective teaching and learning processes;

1. Teachers are using IT-enabled teaching tools, such as PowerPoint and video clips, in addition to the traditional chalk-and-talk method to find students who are interested in new material and practical learning.
2. The library has a sufficient amount of books, journals, e-diaries, and digital publications available. On the university campus, Wi-Fi is available for personal laptops and mobile devices to access the internet.
3. The university library has research journals, reference materials, and textbooks on a variety of topics. Modern technology with the newest operating systems and configurations are available in the university's labs. The university's campus has Wi-Fi with a 730 Mbps bandwidth, and classrooms and seminar halls are equipped with 26 LCD projectors and 13 smartboards.

2.5.3 - IT integration and reforms in the examination procedures and processes (continuous internal assessment and end-semester assessment) have brought in considerable improvement in examination management system of the institution

Abhilashi University is continuously attempting to modify the assessment methods and cycles in order to promote rationality, objectivity, clarity, and prompt resolution of understudies' complaints. In order to survey the understudies in exams, Abhilashi University has used the system of regular evaluation. In consultation with COE, the faculty deans oversee the first and second term assessments. Following evaluation, the COE receives the honor records from the faculty deans.3. If there are any problems with the evaluation of their response scripts, students can apply to the COE. The University ensures that its evaluation framework is foolproof and addresses any objections from understudies by keeping it open to revisions and reinforcing it periodically. All of the assessment framework's exercises have been updated to reflect the modifications made by the administrative entities. The efficient execution of assessment cycles is aided by the automation of examination measures, such as the verification of assessment results, timetables, and expense instalments.

2.6 - Student Performance and Learning Outcomes

2.6.1 - The institution has stated learning outcomes (generic and programme specific)/graduate attributes which are integrated into the assessment process and widely publicized through the website and other documents

The learning objectives of the programs and courses are explicitly defined by the university. Teachers and students are informed of the learning outcomes using the following technique. The department has copies of the syllabus on hand for faculty and students to consult at any time. The faculty discusses the learning outcomes of the programs and courses with students at the conclusion of each study topic, which leads to which technological applications. Using Bloom's Taxonomy, the learning outcomes are articulated in the lesson plan, which outlines the information, abilities, and competencies that students should have from finishing their course of study. For reference, soft copies of the curriculum and learning outcomes for the courses and programs are also posted to the institution's website. At each IQAC meeting, the teachers have been informed of the significance of the learning outcomes. The students become well acquainted in evaluating, designing and developing applications to solve computer science related problems. The program's learning objectives focus on developing learners' proficiency in integrating and using modern IT tools to create computer programs and handle problems effectively.

The program's results and through both direct and indirect techniques, specific outcomes are evaluated using the course outcomes of the pertinent courses. The evaluation mechanisms for each program, which combine formative and summative assessment, are how the university gauges the achievement of the POs, PSOs, and COs. Through formative assessment: The organization uses the ongoing internal evaluation that the university mandates to gauge the achievement of the results. One of the requirements for obtaining POs, PSOs, and COs is the written exam requirement. On the basis of the outcome analysis, the teaching and learning process is reviewed and any necessary improvements are made. They are given first-hand experience and have their theoretical knowledge put to the test. To put it briefly, the institution measures its achievement of POs, PSOs, and COs using a variety of traditional as well as creative and novel approaches. The students' total performance is evaluated and shared with them. Regular observation and internal assessment results are used to identify the students' areas of weakness.

Abhilashi University has implemented a student-centered pedagogy that incorporates immersive, interactive, and problem-solving coaching mastery. In consultation with COE, the faculty deans oversee the first and second term assessments. Following evaluation, the COE receives the honor records from the faculty deans.3. If there are any problems with the evaluation of their response scripts, students can apply to the COE. The University ensures that its evaluation framework is foolproof and addresses any objections from understudies by keeping it open to revisions and reinforcing it periodically. All of the assessment framework's exercises have been updated to reflect the modifications made by the administrative entities. The efficient execution of assessment cycles is aided by the automation of examination measures, such as the verification of assessment results, timetables, and expense instalments.

With a built-up area of 687 square meters, the Abhilashi University Central Library can accommodate 150 members. Departmental libraries of several schools each have adequate space and are staffed by a certified senior librarian and assistant librarian. It also offers a feedback system, and library amenities are enhanced in response to their input. There are many back volumes of scientific and technical publications in the library, along with notable book volumes and titles. In addition, the library has subscriptions to over 10,000 e-books via DELNET, lacs of books through NDLI, and national and international periodicals, magazines, and e-journals. The library provides digital resources for printing and scanning rare and out-of-print books, doctoral theses, and postgraduate dissertations. Faculty publications and other internal publications have also been converted to digital format. The majority of the rare books are in English and Sanskrit. Farmers and the impoverished go to these camps to receive free medical examinations and care. Only when a person receives the appropriate medical examination, screening, and treatment can they expect to live a longer and healthier life. These medical camps offer general physical examinations,

including eye and health examinations, as well as evaluations of the functioning of critical organs such as the heart, lungs, digestive system, liver, kidneys, and immune system, to the impoverished population. For the underprivileged who have low incomes and cannot afford the high costs of healthcare provided by clinics or hospitals, free medical camps are a huge help. The camp's other goals were to raise farmers' awareness of animal health, help them treat their livestock as needed, and develop the animal health industry by implementing vaccination programmes that prevent various livestock and poultry diseases, developing capacity, conducting disease surveillance, and bolstering veterinary infrastructure.
