महोदय,

Please refer to the Department Letter No.K/4/2024-LH (28739) dated 12.9.2025 forwarding therewith Application in Form-X along with enclosures for Renewal of Letter of Permission for 3rd and 4th B.V.Sc.&A.H programme in respect of School of Veterinary Sciences, Abhilashi University, Chailchowk, Tehsil Chachyot, District Mandi, Himachal Pradesh for processing and submit recommendations to the Department.

The said proposal was considered by the Executive Committee of the Council in its meeting held on 23.9.2025 and decided to inspect the aforesaid College under Section 19 of the IVC Act,1984 read with Rule 9(6) of VCI Rules,2017. Accordingly, the College was inspected during the period from 06 – 08 November,2025.

The Inspection Report was considered by the Executive Committee of the Council in its meeting held on 18.11.2025 wherein Committee decided that a copy of the Inspection Report together with observation of the Executive Committee shall be sent to the applicant University for obtaining their comments as provided under Rule 9(7) of VCI Rules,2017. The Council in its meeting held on 12.1.2026 considered the Inspection report together with observation of the Executive Committee and comments/ compliance report received from the applicant University. The decision of the Council is as under:

"The Council considered the compliance report received from the Registrar, Abhilashi University, Mandi, Himachal Pradesh in respect of School of Veterinary Sciences, Abhilashi University, Chailchowk, Tehsil Chachyot, District Mandi, Himachal Pradesh together with the recommendations made by the Executive Committee in its meeting held on 18/11/2025 for the purpose of recommendation for Renewal of LOP.

The Council has gone through the inspection report, observation of the Executive Committee meeting dated 18.11.2025 as well as comments furnished by the Applicant University. The Council observed that the applicant college fulfils the minimum requirements in terms of land, building, infrastructure facilities, LFC, VCC and teaching manpower, laboratories and library facility as provided under VCI Rules, 2017 read with VCI Regulations, 2016.

Hence, Council decided to recommend to the Central Government for Renewal of Letter of Permission for 3rd and 4th BVSc & AH degree course programme for the academic year 2026-27 and 2027-28 in respect of School of Veterinary Sciences, Abhilashi University, Chailchowk, Tehsil Chachyot, District Mandi, Himachal Pradesh as provided under rule 9(8) of VCI Rules, 2017. It was further decided that the inspection report as well as comments received from the applicant University shall also be sent to the Central Government as provided under Rule 9(8) of VCI Rules, 2017."

In view of the aforesaid decision of the Council, I am directed to forward herewith the recommendations of the Council **for issuance of Renewal of Letter of Permission** for the Third and Fourth B.V.Sc. & A.H. in respect of School of Veterinary Sciences, Abhilashi University, Chailchowk, Tehsil Chachyot, District Mandi, Himachal Pradesh under the provision of Rule 9(8) of VCI Rules, 2017..

Further, a copy of the Inspection Report along with compliance/ comments received from the applicant college and the relevant portion of the Minutes of Council meeting dated 12.1.2026 are enclosed herewith for ready reference.
